



## Terms and conditions of the call for start-ups

### for the project Developing Innovative Sustainable Cooperation Opportunities (HEI - DISCO)

#### § 1

##### General information

1. The Terms and Conditions of the call for start-ups for the project Developing Innovative Sustainable Cooperation Opportunities (HEI - DISCO), hereafter referred to as the Terms and Conditions, specifies the project application procedure, the relevant deadlines, the methods of communication with the Project Recruiter, and the requirements for prospective participants.
2. The project Developing Innovative Sustainable Cooperation Opportunities (HEI - DISCO) (hereafter referred to as the Project, has received grant support from the European Institute of Innovation and Technology (EIT) pursuant to Grant Agreement 2021–2022 EIT Climate-KIC.
3. The Project Recruiter, hereafter referred to as the Recruiter, is the Krakow University of Economics acting through its extramural unit Małopolska Szkoła Administracji Publicznej (Malopolska School of Public Administration).

#### § 3

##### Eligible entities

1. Within the framework of the Project, assistance may be provided to:
  - a. start-up enterprises with no more than three years in operation whose activities include innovation,
  - b. persons who declare that they will establish a start-up whose activity will include innovation.
2. Assistance offered as part of the Project shall cover consulting services intended to contribute to the development of the participating enterprise.

3. No financial assistance shall be provided under the Project.

4. Participation in the project is free of charge.

## § 4

### How to apply

1. Interested individuals (Applicants) shall submit an application to participate in the Project in the form of an e-mail that includes the following information:

- a. applicant data / data from an appropriate register,
- b. contact details,
- c. contact persons,
- d. description of activity,
- e. expected forms of assistance (e.g. training, consultancy, search for partners, participation in grant competitions and public tenders),
- f. expected results of assistance.

2. The applications shall be reviewed by the Recruiter.

3. As part of the review process, the Recruiter may request extra clarification and information from the Applicant.

4. The Recruiter determines the Applicant's eligibility for the Project. The decision is final and cannot be contested.

5. The availability of funds designated for this purpose in the Project budget determines the extent of the assistance.

6. Eligible Applicants shall sign a project participation agreement.

## § 5

### Final provisions

1. These Terms and Conditions are subject to amendment.

2. These Terms and Conditions shall be interpreted by the Recruiter.
